POSITION SUMMARY

As part of the Whitecap Dakota Nation (WDN) Governance Affairs department, the General Legal Counsel will provide and manage legal services for WDN governance and programming activities while reporting to the Director of Governance Affairs.

EMPLOYMENT TYPE: Full-time, Permanent.

DUTIES AND RESPONSIBILITIES

The following duties are a summary of the primary responsibilities. The employee may not perform all listed duties and may be assigned additional tasks as needed. In accordance with the standards of the WDN the employee will:

- Manage and implement WDN's long-term legislative agenda, working with Council, Departments and WDN Membership;
- Collaborate with Council, CEO, Governance Affairs, and Program Departments on reviewing and revising existing WDN laws (e.g., Land Code, Membership Code, taxation laws) and developing new laws (e.g., Executive Act, freedom of information laws, non-member representation laws);
- Support intergovernmental negotiations and partnerships including establishing new agreements and arrangements with other governments and outside agencies to support WDN's social and economic development programming;
- Provide legal research and policy support for WDN intergovernmental priorities including Dakota Reconciliation, specific claims, Self Government Treaty Implementation;
- Provide advice on the interpretation and application of WDN Laws and Regulations (including agreements/contracts) to WDN staff and Council;
- Monitor and ensure that WDN Chief and Council and Government departments are following WDN Constitution, laws, policies, as well as other laws of other jurisdictions (Canada and Saskatchewan); as required according to the WDN Self Government Treaty;
- Coordinate advice from external legal counsel where requested;
- Provide general legal advice as necessary to WDN Government and associated entities and engage external legal support where required;
- Demonstrates behaviors, actions and attitudes that are consistent with WDN's vision, mission, and values.

KNOWLEDGE, SKILLS AND ABILITIES

- Minimum of 1-2 years working with Indigenous people as a General Legal Counsel;
- Bachelor of Laws Degree and membership in good standing of the Law Society of Saskatchewan with at least 1-2 years of experience;
- Knowledge and experience in the application of related legal theory and practice;
- Strong critical thinking skills to understand complex fact patterns, identify legal issues and risks, and provide timely advice;
