POSITION SUMMARY

In Accordance with standards of the Whitecap Dakota Nation and Reporting to the Community Health Nurse and the Clinical Integration Manager, the Maternal Child Health / Healthy Living Nurse will deliver health care and educational services within the Whitecap Community, guided by the Whitecap Community Health Plan.

EMPLOYMENT TYPE: Full-time, Permanent.

DUTIES AND RESPONSIBILITIES

The following duties are a summary of the primary responsibilities. The incumbent may not perform all listed duties and may be assigned additional tasks as needed in accordance with the standards of the WDN the employee will:

- Collaborate with an interdisciplinary team and other Health and Social Development providers to support effective case management;
- Assist in the planning, arrangement, and delivery of workshops, clinics, meetings, and health promotion programs within the community;
- Provide support to the Community Health Nurse in pre- and post-natal care, ensuring optimal maternal and child health outcomes;
- Arrange neurodivergent screening and support to children and families during this process;
- Facilitate communication with clients by interpreting and explaining medical treatments or sourcing information to clarify healthcare plans;
- Conduct school visits to deliver hearing and vision screenings, immunization programs, fluoride rinse initiatives, and health inspections;
- Perform health assessments in areas such as dental care, nutrition, sanitation, communicable disease prevention, maternal and child health, and school health.
- Carry out duties of children's oral health initiatives (COHI);
- Maintain accurate and confidential records, adhering to policies for Electronic Medical Records (EMR) and Health Canada's Community-Based Reporting Template (CBRT);
- Make referrals to appropriate agencies, service providers, or Environmental Health Officers to address community concerns such as water quality, pest control, and fire safety;
- Participate in ongoing professional development, including training in Med Access (EMR) and other relevant programs, to enhance service delivery; and
- Attend staff and health committee meetings to contribute to strategic planning and community health initiatives.
